

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to murdermysteryquilt.com and Whipstitch Industries, LLC d/b/a The Murder Mystery Quilt and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Whipstitch Industries, LLC/The Murder Mystery Quilt include murdermysteryquilt.com and The MMQ. The The MMQ website is a ecommerce site. By using the The MMQ website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, The MMQ may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase The MMQ's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through The MMQ's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site.
